Bank balances:

Core \$ 10,044.82

I renewed the PO box for a year, so this will have to come out of this balance \$226.45

The junior and senior SportsEngine registrations were deposited to the Core account. I am working with both treasurers to confirm amounts and send funds to those accounts.

The number above DOES NOT include those deposits.

Raffle \$882.67

This is used for any raffles held (Queens general raffle, U18AA Queens raffle).

Licenses are applied for for each raffle prior. Chantal works with the city on each of these for reporting and payout of funds, etc.

Nevada \$3,142.70

I spoke to Matthew Van Ramshorst (City License officer) about the Nevada account. We have not had any location or license to sell Nevada tickets since before I started as treasurer. He indicated that these funds could be used for junior ice (with documentation and receipt/contracts for ice).

Please add this as a discussion point for next meeting to maybe allocate \$1500 to each junior and queens for ice payments. These cheques will have to go directly to City or FN for payment of specific invoices.

Then we can look at closing this account.

Competitive Report – Meeting October 24, 2023

- CEDC Short Form Application for Funding was accepted, we have been invited to submit
 a full budget and present. Requesting Tourism Event Funds for hosting two showcase
 weekends, regional High School teams and Winnipeg x2. Fund up to 25%
- Northwestern Ontario Sports Hall of Fame Induction was a success. The replica Championship banner was produced and shipped in time for the ceremony (now hanging at FWFN). Souvenir programs turned out great. Both congratulatory messages where together on the page.
- Signage / Title Sponsors are displayed at FWFN (Queens Dressing Room). Working on digital signage to recognize the gold sponsors.
- Rosters all approved. Provincial Bond submitted and payment sent (includes U15Fury and U18 Fury)
- Teams are starting to travel. U18AA won the Durham North American Showcase a few weeks ago, that same weekend the U15A team won tournament in Sault Ste Marie. U15AA has had a few exhibition series in Duluth. Remaining teams will be travelling starting November.
- U22 Queens joined Sr. Women's League A Division.
- U15A have been denied entry into Westfort and Elks Tournaments in the last few weeks (registered in the U13AA Division, equivalent to level they play interlock). This year they are believed to be "too strong" for the level. Appeal letter submitted by the board after consulting with legal. Request Denied. U11 Queens denied entry in U11A KC Tournament. At present time, U11 is still registered in the Westfort U11AA, and U13 is in the Westfort and Elks U13AA.
- Interlock Games compromised (update not yet available).
- Player and Goalie Development Sessions will run monthly for each team. First one started on October 19th. Kaity Howarth is running the player skills and Megan Leikkari is doing the goalie development. Will continue to build on in the coming months with coach feedback. Instructors have volunteered their time; ice is being covered by the Queens board.
- Concerns for U15 level next year NO GOALIES. Discuss with OWHA options for late birth player option. USA Hockey (birth date June 1st, team would be eligible to play state side). Regional Goalies (recruitment).
- Working on an updated Alumni list.

We have had only 9 refund requests. Our total number is 177 registered TBWHA hockey players. Happy to say we are up in numbers compared to last year.

Happy to announce everyone who registered for woman's hockey is playing hockey. Zero players were refused.
